TESTING AND SCOPE OF TESTING.

Product testing is carried out as part of an initial testing in accordance with the requirements of the international standard [DIN EN ISO 17225-2](#) by a testing laboratory that is recognized by us. The properties tested include water content, bulk density, abrasion behavior and ash melting temperature.

ASSESSMENT AND CERTIFICATION.

Upon successful assessment by our experts, a certificate is issued together with the right to use the DINplus mark with an individual registration number and a validity period of five years.

MONITORING.

The periodic monitoring of the manufacturing facility is an important element of the DINplus certification. As a third-party monitoring body, we carry out an inspection of the manufacturing plant at least once a year to verify proper self-monitoring. As part of this factory inspection, our experts also take a product sample for random testing. Save costs and time by combining inspections, e.g. when you commission DIN CERTCO to conduct a PEFC certification for wood pellets at the same time.
