# Certification - DIN-Geprüft Biodegradable in Soil DIN-Geprüft Home Compostable.

#### DIN-Geprüft Biodegradable in Soil.

This certification refers to manufactured goods that are biodegradable in the soil. These goods include mulch films, materials or semi-finished items. Basis for testing is the DIN EN 17033:2018-03 and the certification scheme.



#### **DIN-Geprüft Home Compostable.**

DIN-Geprüft Home Compostable certification mark is awarded to products that can be composted at low temperatures, for example in the garden. These products can be for example shopping bags, packaging, and films or granulates. The basis for testing are the Australian national standard AS 5810, the French national standard NF T 51-800, and the certification scheme.

By using our independent certification marks, you as a manufacturer or supplier are proving that your products meet specified requirements and that they undergo regular inspections to ensure on going conformity to these requirements.
