"DIN-Geprüft" certification of wood pellets for commercial use.

In the industry of today, wood pellets are considered a real alternative to heating oil and natural gas. In comparison to small-scale furnaces, where as a rule DIN*plus* quality is employed, the quality demands placed on the use of pellets in large-scale heating systems and power plants are different.

The mark that shows the difference.

In contrast to wood pellets of DIN*plus*- quality, class-B pellets, known as wood pellets for commercial use, may contain woody biomass from forest and plantation wood, other freshly cut wood, industrial waste wood and used wood. Foreign substances are also allowed, as long as they do not contain any heavy metals or halogenated organic compounds as a result of treatment with wood preservatives or due to coatings.

As a manufacturer of wood pellets for commercial use, there is no need for you to do without neutral quality assurance. Certification and "DIN-Geprüft" industrial pellets enable you to document the fact that an independent, neutral and competent body has carefully examined and evaluated the testing criteria, that you supply products of consistently high quality and that you submit to regular inspections.

Testing and scope of testing

The product testing is conducted according to the property class-B requirements of E DIN EN 14961-2:2010-07 as part of an initial test by a testing laboratory recognized by DIN CERTCO.

Assessment and certification.

After a successful assessment by DIN CERTCO, a certificate and the right to use DIN-Geprüft "Industriepellets" are awarded, with an individual registration number and a validity period of five years.

Monitoring.

Monitoring of the quality assurance measures of the manufacturing facility is an important element of the "DIN-Geprüft" certification. The external monitoring body conducts an inspection of the manufacturing facility initially, after two years and after five years for extension of the certificate. Additionally, a product sample is taken annually for a random test.

Openness and transparency.

An up-to-date list of all holders of a DIN CERTCO certificate can be viewed on the DIN CERTCO website. All the documentation relating to certification, such as the certification scheme and application form can also be accessed here.
