## DIN-Geprüft certification for desiccant bags.

With national and international goods traffic steadily increasing, protecting products and industrial goods from moisture, corrosion and mould during storage and transport is becoming a particular and increasingly important concern. Industrial goods are often transported long distances before they arrive at their actual destination. Desiccant bags can preserve the quality of your product even on long transport journeys.

### The mark that shows the difference.

The use of DIN-approved desiccant bags protects your products effectively during both transport and storage. With DIN-approved desiccant bags it is safest to take into account DIN 55473 when calculating your specific requirements.

With the certification and the DIN-Geprüft mark you can provide written proof that you work to an extremely high standard, offer consistently high product quality and undergo regular inspections.

### Testing.

The initial certification involves a production-site and accordingly a warehouse inspection and independent sampling. Among other measures, the following tests are conducted by a DIN CERTCO accredited testing laboratory

- Adsorption capacity and speed
- Volume and mass
- Dust permeability
- Bag strength

### Monitoring.

Monitoring is ensured through a regular production-site and accordingly a warehouse inspection and sampling activities. During this inspection, the implementation of the standard and the quality assurance measures with regard to the production-related internal controls are monitored and inspected. The samples taken on site are tested by an independent DIN CERTCO accredited testing laboratory in accordance with the requirements.

### Assessment and certification.

After a successful assessment by DIN CERTCO a certificate and the right to use the DIN-Geprüft mark are awarded with an individual registration number and a validity period of five years.

### Openness and transparency.

A daily updated list of all certificate holders can be viewed on the homepage of DIN CERTCO. From here it is also possible to download all documents relevant to certification, such as the certification scheme and application.
