



Schedule of fees for certification of thermal insulation products for industrial installations

valid with effect from 01.05.2022

1 General

The following fees apply to normal services provided by DIN CERTCO. The charges for these services take the form of fee units (**FU**). In the applicable [Standard Fee Unit of DIN CERTCO](#), the currently valid price per fee unit can be found.

Payment of the fees is due as soon as the account is rendered and is usually charged on the basis of the following positions:

- Initial certification = (2) + (3) + 4 + 5.1 + 6 + 7
- Surveillance = (2) + (3) + 5.2
- Renewal = (2) + (3) + 4 + 5.3 + 6
- Annual (following the award of the certificate) additionally = 7

The positions in brackets only apply to services which are ordered or carried out by DIN CERTCO. The fees shall be determined based on the following definitions:

1. Product: All products that are distinguishable on the basis of certification-relevant characteristics and thus are distributed under its own trade name. For each type an independent certificate shall be issued.
2. Type: All products, for which the KEYMARK or the mark "überwacht nach VDI 2055" is applied in accordance with the relevant EN product standard.
3. Sub-type: All products with one of the following delivery forms are defined as sub-type:
 - a) mat (includes mats, wired mats, rolls, felt, mattress and quilt, sheet)
 - b) pipe (pipe section, tube)
 - c) board (includes board, slab and batt)
 - d) lamella mat (delivery form)
