



## Schedule of fees for the certification of ceiling mounted radiant panels - KEYMARK

valid with effect from 01.05.2022

### 1 General

The following fees apply to normal services provided by DIN CERTCO. The charges for these services take the form of fee units (**FU**). In the applicable [Standard Fee Unit of DIN CERTCO](#), the currently valid price per fee unit can be found.

Payment of the fees is due as soon as the account is rendered and is usually charged on the basis of the following positions:

- Initial certification = (2) + (3) + 4 + 5.1 + 6 + 7.2
- Surveillance = (2) + (3) + 5.2 + 7
- Renewal = (2) + (3) + 5.3 + 6 + 7

The positions in brackets only apply to services which are ordered or carried out by DIN CERTCO.
