



Schedule of fees for the certification of thermostatic radiator valves

valid with effect from 01.01.2025

1 General

The following fees apply to normal services provided by DIN CERTCO. The charges for these services take the form of fee units (**FU**). In the applicable [Standard Fee Unit of DIN CERTCO](#), the currently valid price per fee unit can be found.

The fees base of the following definitions:

1. Type: A thermostatic head or valve bodies is defined as type.
2. Subtype: A thermostatic head or valve bodies, according the following criteria, is defined as subtype/design variant.

Thermostatic head:

- with integral sensor
- with integral temperature selector with remote sensor
- with remote sensor incorporating the selector
- with remote sensor and with remote sensor
- chrome plated

Thermostatic valve:

- without presetting facility
- with presetting facility
- with dimensions, material and details on connection to EN 215, Annex A, Series D
- with dimensions, material and details on connection to EN 215, Annex A, Series F
- with dimensions, material and details on connection to EN 215, Annex A, Series S
- with dimensions, material and details on connection to EN 215, Annex A, Series GB
- with dimensions, material and details on connections not complying to series D,F,S,GB
- Integrated

Payment of the fees is due as soon as the account is rendered and is usually charged on the basis of the following positions:

- Initial certification = (2) + (3) + 4 + 5.1/5.2 + 6 + 7
- Surveillance = (2) + (3) + 5.3/5.4
- Renewal = (2) + (3) + 4 + 5.5/5.6 + 6
- Annually (from the year following the award of the certificate) in addition = 7

The positions in brackets only apply to services which are ordered or carried out by DIN CERTCO.
