Market approval for Arabian Gulf States.

The States of the Persian Gulf are some of the most rapidly expanding countries in the global economy. These are renowned worldwide for their oil reserves and their massive import volume. Saudi Arabia.

The majority of consumer products exported from Germany to Saudi Arabia require a Certificate of Conformity (CoC) as evidence of the product's compliance with Saudi Arabian regulations. This certificate must be presented to the customs authorities when imports are made to Saudi Arabia.

Since mid-October 2008, DIN CERTCO has been approved by "SASO" to issue Certificates of Conformity (CoC) for Saudi Arabia as an assessment body in Germany.

If incoming freight does not comply with the regulation, it cannot be imported into Saudi Arabia.

Kurdistan.

The economy in Kurdistan, the autonomous territories in northern Iraq, is growing significantly. Large investments are especially being made in the infrastructure, the energy sector and also in industrial facilities.

TÜV Rheinland and DIN CERTCO were asked by the "Kurdistan Standardization and Quality Control Administration" (KSQCA) to issue each and every product imported via Kurdistan a "Certificate of Conformity" starting from 15th September 2014.

The "Certificate of Conformity" guarantees that a minimum level of safety as well as the ethnical regulations on the subject of consumer protection and environmental compatibility are fulfilled.

Iraq.

Effective from 1st January 2013, DIN CERTCO issues "Certificates of Conformity" for all products that meet the Iraqi safety requirements.

TÜV Rheinland has been appointed by the Central Organization for Standardization and Quality Control (COSQC) in Iraq for pre-inspection, testing and issuing Certificates of Conformity of goods imported into Iraq.

The Program of Goods Imported into Iraq ICIGI (Pre-Import Inspection, Testing and Certification Program of Goods to Iraq) will cover 12 product categories focusing on both Iraqi national standards and international requirements. The program will ensure that all products entering Iraq will meet a minimum level of safety for both consumers and the environment.

Kuwait.

In 2006 the "Kuwait Conformity Assurance Scheme" (KUCAS) was introduced. Since that time, compliance with the technical requirements of Kuwait has had to be proven for certain product groups depending on the delivery.

The confirmation occurs by using the Certificate of Conformity from the relevant authority "Public Authority for Industry" (PAI). PAI requires "Technical Inspection Reports" (TIR), which can be issued by TÜV Rheinland.



Steps for obtaining the Certificate of Conformity for the Arabian Gulf States.

- 1. Apply to DIN CERTCO
- 2. Review the technical documentation and the goods if applicable
- 3. Register the product
- 4. Carry out shipping inspections if necessary
- 5. Issue the Certificate of Conformity
